Modern slavery act 2015 Statement on slavery and human trafficking

AAR International, Inc. (the Company or we), is a leading provider of aviation services to commercial and government operators, MROs and OEMs, and is a wholly-owned subsidiary of AAR CORP. (NYSE: AIR). AAR CORP. has approximately 5,700 employees and operates globally.

Our business and supply chains

AAR CORP. ("AAR") is a global aerospace and defense aftermarket solutions company that operates in more than 20 countries. Headquartered in the United States, near Chicago, AAR supports commercial and government customers through four operating segments: Parts Supply, Repair & Engineering, Integrated Solutions and Expeditionary Services. Parts Supply consists of sales of used serviceable engine and airframe parts and components and distribution of new parts; Repair & Engineering consists of maintenance, repair, and overhaul services across airframes and components, including landing gear; Integrated Solutions consists of fleet management and operations of customer-owned aircraft, customized performance-based supply chain logistics programs in support of the U.S. Department of Defense and foreign governments, flight hour component inventory and repair programs for commercial airlines, and integrated software solutions including recently acquired Trax USA Corp. Expeditionary Services consists of products and services supporting the movement of equipment and personnel by the U.S. and foreign governments and non-governmental organizations.

In FY 24, we utilized a broad base of suppliers, across the United Kingdom, the United States, Canada and approximately 40 countries.

Our policies on slavery and human trafficking

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business. Our Code of Conduct and Anti-Slavery and Human Trafficking Policy reflect our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place anywhere in our supply chains. Due diligence processes for slavery and human trafficking

We have in place systems to:

- Identify and assess potential risk areas in our supply chains.
- Mitigate the risk of slavery and human trafficking occurring in our supply chains.
- Monitor potential risk areas in our supply chains.
- Protect whistle blowers.

Supplier adherence to our values

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our values we have committed to putting in place a rigorous supply chain compliance programme. This consists of:

- a. Conducting risk assessments to determine the parts of our business and any of our suppliers who are most at risk of modern slavery.
- b. Engaging with suppliers to convey to them this statement and our Anti-Slavery Policy.
- c. Introducing where appropriate contractual obligations on our suppliers to confirm their adherence to this statement.

We have a dedicated compliance team, which consists of involvement from the following departments:

- Legal/Compliance
- Audit
- Human Resources
- Procurement
- Finance
- Sales

Training

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we provide training to our staff.

Further steps

Following a review of the effectiveness of the steps we have taken this year to ensure that there is no slavery or human trafficking in our supply chains, we continue to identify, on a risk-approach basis, suppliers in areas of perceived greater risk, and require new suppliers to complete due diligence reviews, and require that suppliers affirm compliance with applicable modern slavery laws.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes our slavery and human trafficking statement for the financial year ending 31 May 2024. This statement was approved by the Board on October 16, 2024.
